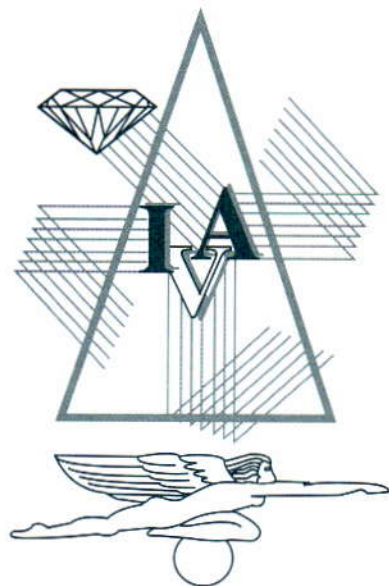

1 A ROUND BRILLIANT CUT DIAMOND RING, six claw set in 18ct white gold with four round brilliant cut diamonds bead set down each shoulder within a millegrain border to a 3.4 to 2.5mm tapered shank. Hand-pierced collet. GIA grading report 15317662 and dated September 20, 2006 stating:-
